NOTICE OF MOTION

1. EQUAL, LIFE, LIBERTY, and THE PURSUIT OF HAPPINESS

As Mazzoli and Lewis follow me and threaten me by direct interference
Of employment, marriage, health, and education.

5. We move the 8th Amendment, CRUEL and UNUSUAL PUNISHMENT,
Mazzoli and Lewis are engaging in activities after being told by Special
Agent Juan Serrata, Las Vegas, Nevada, EEOC that I did not have a
Disability as Mazzoli and Lewis failed to stay in NYS, they live in NYS
And I reside in Las Vegas, Nevada with my husband as Mazzoli and Lewis
Threaten me daily after being told OUT of NEVADA

6. JoAnn O’Neil, My Aunt, Head of The London CIA, caught Lewis
And mazzoli trespassing into a Federally Protected ZONE at Arizona
Charle’s Casino where I was employed as a food server. The CIA caught
Them and ordered them out of here as I move the State of Nevada,
As the State knows they are doing this out of deceit, fraud, bigotry,

O'Neil has communicated to Mazzoli on a recorded line that Mazzoli And Lewis are NOT under any reason to use her deceased mother, Josephine wahrendorf to interfere with my health, marriage, happiness Or rights. Mazzoli has ignored it. Mazzoli fails to communicate to Lewis hey, we shouldn't do this, I am being sued, instead Mazzoli Encourages and endorses the violating of a Federal restraining order Issued by The United States Navy to intentionally trespass into a Federally Protected Zone with the intent to threaten, place fear, Intimidate, as mr. Beck cannot control his out of control client as Charlene O'Neil knows she is doing it and

10. Mazzoli is calling me a homosexual child, by constant threats. Las Vegas Metro has been called and criminal charges were filed for threats to Kill the homosexual child by Mazzoli and Lewis

11. Mazzoli also conspired to obstruct and interfere with employment as A mechanism of human trafficking by intentionally intending to obstruct, Interfere, and hinder stability by intentionally forcing movement as Investigated by JoAnn O'Neil, head of The London CIA.
