16 (a) Appellant’s sentence was, in addition to the \$25.00 Administrative Assessment  
17 Fee, \$741.58 Restitution and \$150.00 DNA Analysis Fee including testing to determine genetic  
18 markers plus \$3.00 DNA Collection Fee, for Count 1, Attempt Murder with Use of a Deadly  
19 Weapon (Category B Felony) in violation of NRS 200.030, 193.330, 193.165, a maximum of  
20 twenty years with a minimum parole eligibility of eight years, plus a consecutive term of twenty  
21 years with a minimum parole eligibility of eight years for the Use of A Deadly Weapon, and  
22 Count 2, Assault with a Deadly Weapon (Category B Felony Felony) in violation of NRS  
23 200.471, a maximum of seventy-two months with a minimum parole eligibility of sixteen  
24 months, concurrent with Count 1; with five hundred thirty-six days credit for time served.

25 (b) The sentence has not been stayed pending appeal.

26 (c) Defendant was not admitted to bail pending appeal.

27 3. Counsel in the district court was appointed.
