

8. Appellant was charged by way of Information, pursuant to plea agreement with CHILD ABUSE. The original charges were for Sexual Assault and related charges. Sentencing was on July 13, 2021 and a written Judgement of Conviction was entered on July 21, 2021. Notice of Appeal filed on August 19, 2021.
9. The District Court case was a criminal matter, resulting in a Judgment of Conviction.
10. This case has not previously been the subject of an Appeal, and was not originally a Writ proceeding.
11. This appeal does not involve child custody or visitation.
12. At this time, there is no possibility of a settlement.
