APPELLANTS' MOTION TO STAY BRIEFING SCHEDULE PENDING RESOLUTION OF THE STAY OF PROCEEDINGS IN THE UNDERLYING DISTRICT COURT AND ADJUDICATION OF FORECLOSURE PROCEEDINGS

Appellants Spanish Heights Acquisition Company, LLC ("SHAC") and SJC Ventures Holding Company, LLC ("SJC Ventures") respectfully file this motion to stay the appeal briefing schedule pending the resolution of the stay of proceedings in the underlying district court case and the adjudication of foreclosure proceedings, which may obviate the need for this appeal.

Good cause supports the granting of this motion for the following reasons:

1. On August 18, 2021 Appellants filed their Notice of Appeal, appealing the order appointing a receiver over SHAC entered into the Eighth Judicial District Court on August 10, 2021.

- 2. The case was transferred to the Settlement Program; the parties were unable to reach a settlement. As such, the briefing was reinstated by the Order filed on September 28, 2021.
- 3. The underlying district court case was still moving forward to resolve the remaining issues not addressed in the May 7, 2021 Findings of Fact and Conclusions of Law, which is the subject of a separate appeal that has already been stayed (Case No. 82868).
- 4. On November 16, 2021, the Parties reached a settlement agreement on all claims, and the material terms were placed on the record.¹
- 5. As part of the settlement, the Receiver was excused from performing additional work pending the January 11, 2022 status check hearing or further order of the Court. Ex. 1.
- 6. Appellants were unable to make all of the scheduled payments with respect to that settlement agreement, and as a result, Respondents have indicated that a foreclosure sale of the Property at issue is set for February 1, 2022.
- 7. Accordingly, additional litigation will be ensuing in the underlying district court with respect to the impending foreclosure sale, beginning with a status check set for January 11, 2022, the results of which may impact the receiver's actions and work, which may obviate the need for this appeal.
- 8. Appellants are therefore requesting a thirty (30) day stay of the briefing schedule, to allow for the underlying litigation on the foreclosure sale to take place,

which may obviate the need for this appeal.

- 9. No party will be prejudiced by the granting of the requested stay, which is sought in an effort to allow completion of the underlying litigation on the potential foreclosure of the property at issue.
- 10. Appellants believe that a stay of proceedings is appropriate to avoid potentially unnecessary further litigation and to conserve judicial resources.
