IT IS HEREBY ORDERED that the Defendant's Motion to Appoint Counsel, shall be, and it is DENIED for the reasons primarily stated in the State's opposition. Further, the reasoning for appointing counsel is not provided by the Deft., as we know there has not been a Habeas Corpus Petition filed, there does not appear to be a legal basis upon which he would need appointment of counsel, do understand he filed Motion for Modification of Sentence but again, we do not see any legal basis to allow that to proceed, there are procedural bars that he has been unable to overcome, does not see where appointment of counsel would change facts or circumstances.
