MOTION FOR EXTENSION OF TIME TO FILE DOCKETING STATEMENT

Appellant Kathleen June Jones, by her undersigned counsel, hereby moves this Court for an extension to file her docketing statement pursuant to NRAP 14 until five (5) days from the date of the Order granting this Motion.

1. Appellant filed her Notice of Appeal on September 17, 2020. Pursuant to Nevada Rules of Civil Procedure 14(b), Appellant was required to file the Docketing Statement within 21 days of docketing of the appeal. At the end of September 2020, the undersigned counsel accepted this matter from Legal Aid Center of Southern Nevada, and in the process of the placement and transition, the undersigned counsel did not properly calendar the due date for the docketing statement. (A supporting declaration by the undersigned is being submitted herewith.)

2. The undersigned counsel filed the docketing statement on October 15, 2020, and it was rejected later that day as untimely.

3. In the meantime, Appellant, represented by the undersigned, has been participating in good faith in the Court's settlement program, including by attending a settlement conference on October 16, 2020.

4. Pursuant to Rule 14(d), Appellant submits that good cause exists for Appellant to be permitted to file the docketing statement and have it be deemed timely. The docketing statement became due for filing in the midst of the transition of the case between counsel for Appellant, and the deadline was inadvertently missed as a result of the transition process. This Appeal is at its inception, and Appellant made an attempt to file the docketing statement only approximately one-week beyond its due date. Given this short delay, together with the nature of

the docketing statement as a means for the Court to address procedural rather than substantive matters, *see* Rule 14(a)(3), no prejudice will result to any other party to this Appeal if the docketing statement is permitted to be filed now.
