
13 Plaintiff filed a Motion to Enroll Child in a School That is Beneficial to the Child
14 and Equal Distance from Both Parent's Home and Other Related Relief (August 9,
15 2021) (hereinafter referred to as Plaintiff's "Motion Re: School Selection"). Plaintiff
16 also filed a Motion for Reconsideration, Reopen Discovery and Other Related Relief
17 (Aug. 9, 2021) (hereinafter Plaintiff's "Motion for Reconsideration"). Plaintiff's Motion
18 Re: School Selection and Motion for Reconsideration are scheduled for separate hearings
19 on September 15, 2021 (at 9:00 a.m. and 10:00 a.m. respectively).

21 This Court's Findings of Fact, Conclusions of Law and Decree of Divorce (Jul. 26,
22 2021) was appealed. *See* Notice of Appeal (Aug. 24, 2021) (hereinafter "Decree of
23 Divorce"). Plaintiff's Motions are related to provisions of the Decree of Divorce. In this
24 regard, the issues raised by way of the foregoing motions are *not* ancillary to the issues
25 on appeal. Due to the appeal, this Court is divested of jurisdiction to entertain the relief
26 sought by Plaintiff.

1 Accordingly, and good cause appearing therefore,

2 It is hereby ORDERED that Plaintiff's Motion Re: School Selection and Motion
3 for Reconsideration are DENIED, and the hearings scheduled on September 15, 2021
4 are VACATED.
