MOTION TO EXTEND TIME TO SUBMIT FAST TRACK STATEMENT

PENDING ADMISSION TO APPEAR

COMES NOW, ANIELA K. SZYMANSKI, ESQ., Attorney for Appellant YOAV EGOSI (hereinafter referred to as AAppellant@), and hereby submits the following Motion for Extension of Time to prepare and submit a Fast Track Statement pursuant to NRAP 3E(f)(3).

Undersigned counsel was retained to represent Appellant on or about October 6, 2021. Approval by this Court is still pending as of this date.

It appears based on the length of time between the Notice of Appearance of counsel for Respondent and the Order recognizing her as counsel, that undersigned counsel may not be recognized as counsel until on or about October 27, 2021, some 16-days after the Fast Track Statement is due to be filed. Appellant is not prepared to continue in an unrepresented manner due to the issues involved.
