**MOTION TO EXTEND TIME TO
FILE NOTICE OF PAYMENT OF
TRANSCRIPT DEPOSIT**

8 Appellant, Robert Reynolds, by and through his counsel, F. Peter James,
9 Esq., hereby moves this Honorable Court to extend the time to file the Notice of
10 Payment of Transcript Deposit.

11 **POINTS AND AUTHORITIES**

12 Requests for relief must be made by motion absent another way prescribed
13 by rule. *See* NRAP 27(a)(1). Motions to extend briefing are not favored. *See*
14 NRAP 31(b)(3). Generally, a request for an extension of time to file a document
15 must be made before the deadline has passed. *See* NRAP 31(b)(3). For good
16 cause shown, however, the Court may extend the time for filing a brief even after
17 the deadline has passed. *See* NRAP 26(b)(1)(A).

18 Here, the transcript deposit was due on December 8, 2021. There was a
19 delay in getting the proof of this filed, though the payment was made timely. (*See*
20

1 Notice of Payment of Transcript Deposit filed concurrently, which was rejected
2 on December 20, 2021).

3 It is normal office practice to pay for the transcripts from the office.
4 Counsel for Appellant has filed numerous appeals. In the present matter,
5 Appellant paid for them directly. There were issues getting the receipt for the
6 same. Once Counsel's office obtained the receipt, the notice was filed shortly
7 thereafter.

8 Only the notice of payment was delayed, not the payment itself. The
9 transcripts are on their way and were timely paid.

10 Appellant seeks permission of the Court to file the Notice of Payment of
11 Transcript Deposit after the given deadline. The same was submitted on
12 December 19, 2021, but rejected on December 20, 2021. The same is attached
13 hereto.
