

SELL HEARING (ADMINISTRATION OF MEDICATION)

Deputy D.A. Roy Stralla and Deputy D.A. Nickolas Graham represented the State.

Defendant was present with counsel, James Leslie, Deputy P.D. and Jaclyn Millsap, Deputy P.D.

The Court directed counsel to proceed on the State's Motion to Permit Involuntary Administration of Medication to Defendant.

Counsel Stralla informed the Court that Dr. Henson was present and available to testify.

**Dr. Howard Hale Henson**, called by the State, was sworn, testified and cross-examined by defense counsel Millsap.

Counsel Stralla presented argument in support of the State's Motion and discussed related case law and Ninth Circuit rulings related to the involuntary administration of medication; the State addressed the Court regarding what this Court needs to consider under Sell v. United States; the State discussed Defendant's criminal history and the elements of the offense committed herein. Counsel Stralla further suggested that Defendant could be monitored and if he becomes competent, the State would request that Defendant remain at Lake's Crossing pending resolution of this case.

Counsel Millsap addressed the Court regarding the elements of Sell which must be considered by the Court. Counsel Millsap responded to the Court's comments and questions and argued that the State did not provide a substantial argument that forced medication would assist in Defendant attaining competence. Additionally, defense counsel addressed the issue of whether forced medication was medically appropriate, stating that there were less intrusive means that could be taken before resorting to forced medication.


