Proposed Amici Curiae Nevada Hospital Association, Sunrise Hospital, Mountain View Hospital, Southern Hills Hospital, Valley Health System, LLC, Renown Regional Medical Center, Renown South Meadows Medical Center, and Dignity Health D/B/A St. Rose Dominican – Rose De Lima, St. and Rose Dominican – Siena, St. Rose Dominican – San Martin, submit their motion for a 24-hour extension of the 30-day deadline imposed by this Court in its Order dated December 3, 2021, for the filing of the Proposed Amici's Motion for Leave to File an Amicus Brief, and to file the Amicus Brief, from January 3, 2022, to January 4, 2022. This is the second request for leave to file beyond the statutory deadline for a proposed amicus brief.
