## UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE OPENING BRIEF AND APPENDIX

Appellant Clark County School District requests an extension through May 3, 2022, to file its opening brief and appendix. NRAP 31(b)(3). This is the first such motion following the parties' stipulation. Without an extension, the brief would be due March 4, 2022. No requests for extension have been denied or denied in part.

Respondents' counsel does not oppose this request. His professional courtesy is greatly appreciated.

Good cause justifies the extension. Although counsel have substantially completed a draft of the brief, additional time is necessary.

Two of the attorneys, lead appellate counsel and the attorney primarily responsible for drafting the brief, are out of state. A third attorney has

been unable to assist because of the press of a trial, which following the expiration of certain COVID restriction was expedited to begin next week. And while a fourth attorney has been enlisted to assist with the draft, he has been delayed by family and other obligations (following a long struggle, a beloved family pet died) and was unable to complete review of the draft.

While counsel aim to complete their revisions of the brief diligently, they learned just yesterday that this Court scheduled back-to-back oral arguments in two other appeals, Docket Nos. 81344 and 82467/82552 (consolidated). Preparation for those arguments—on top of the ordinary press of preparing for other trials, appellate briefs, and post-judgment motions in other cases—will unfortunately take time from the preparation of this brief. Appellants therefore request a reasonable time to complete the brief following those oral arguments.
