**UNOPPOSED MOTION FOR EXTENSION OF  
TIME TO FILE REPLY BRIEF**

Appellant Clark County School District requests 30 days, through December 19, 2022, to file its reply brief. NRAP 31(b)(3). This is the first such motion following the parties' stipulation. The parties previously stipulated to extend the deadline pursuant to NRAP 31(b)(2). The brief was originally due October 19, 2022, and without this requested extension, would be due November 18, 2022. No requests for extension have been denied or denied in part.

Appellant's counsel conferred with counsel for respondents, and respondents' counsel does not oppose this motion. This professional courtesy is sincerely appreciated.

There is good cause for an extension. Although counsel have substantially completed a draft of the brief, additional time is necessary.

Appellant's lead counsel has not yet been able to finalize the draft due to preparation for an argument before the Ninth Circuit on November 18, 2022. In addition, the attorney most familiar with the underlying case—and who drafted the opening brief—has now left the firm, necessitating responsibility for drafting to other attorneys.

Appellant respectfully requests that the Court grant this extension to allow appellant's counsel to finalize the brief.
