14 Reconsideration and/or Clarification on August 5, 2021. An Order clarifying was issued by the
15 Sixth Judicial Court on September 8, 2021, dishonorably discharging the Appellant and denying
16 the Petition. Appellant's discharge date from probation should be December 18, 2017 not
17 September 8, 2021.
