15 COMES NOW, Appellant, TERESA ANN GREVELLE, by and through her
16 attorney of record RENDALB. MILLER, of MILLER LAW INC., and respectfully
17 requests this Court accepts the late filing of Transcript Request.

18 This Motion is made and based upon the following facts), as well as all papers
19 and pleadings on file herein:

- 20 1. On October 5, 2021, a Request for Transcript was filed in the Sixth Judicial
21 District Court.
- 22 2. On February 9, 2022 a Notice of Request For Transcript was filed with the
23 Supreme Court of Nevada. This filing included a copy of the filing of the
24 Request for Transcript that was filed in October 5, 2021, in the Sixth
25 Judicial District Court. This filing was rejected.
- 26 3. On February 17, 2022, a Request for Transcript was again filed with the
27 Supreme Court of Nevada. This filing included additional information
28 regarding who the Request For Transcript was submitted to in the Sixth
Judicial District Court. This filing was again rejected.
4. On February 23, 2022, after review of the NRAP, a call was made to the
Supreme Court of Nevada's court clerk. Miller Law, Inc. spoke to Monique


1 to discuss the rejections. Monique stated that a file stamped copy as
2 provided on February 9, 2022, was need and that the information regarding
3 the judicial assistant being the party the request should be submitted to in
4 the Sixth Judicial District Court was also required. Monique stated that
5 submitted both documents together would be sufficient and requested
6 Miller Law, Inc. efile them for her review after the call. Miller Law, Inc.
7 attempted to efile the document multiple times and was given the error that
8 the Supreme Court of Nevada's website was not available. A call was made
9 to the Supreme Court of Nevada's court clerk. They stated that the website
10 was down, a repair ticket was submitted to the IT department, and they
11 would not know if the site would be back up given that it was late in the
12 day. The court clerk confirmed that the request for transcript was due
13 today. The website was still down at the end of business on February 23,
14 2022.

15 WHEREFORE, based upon the foregoing it is respectfully requested that this
16 Court issue an Order allowing the late filing of the Request For Transcript. Finally,
17 Appellant submits that the instant Motion is not made to cause any undue delay but
18 is made solely in the interests of justice.
