**MOTION FOR EXTENSION OF TIME TO FILE REPLY**

Petitioners request a 60-day extension, through February 25,  
2022, in which to file the reply brief on the writ petition. NRAP  
31(b)(2). This is the first such request. The reply brief would otherwise  
be due December 27, 2021.

Good cause warrants the extension. On top of the ordinary press and staffing shortages associated with the holiday season, one of counsel's appellate staff and a family member of the attorney tasked with drafting the reply have fallen ill, requiring the attorney to cancel plans and take significant time away from work.

In addition, petitioners' reply has to respond to two, separately filed answers of the Sherwood real parties in interest and the Ben-Kely real parties in interest. Although both sets of plaintiffs disagree with the petition, they make different arguments. The requested extension will assist in allowing petitioners to file a consolidated reply that addresses the arguments in both answers.
