IT IS HEREBY STIPULATED AND AGREED by PAMPT, LLC (“Appellant”) and Respondents Kenneth F. Potashner, VTB Holdings, Inc., Stripes Group, LLC, SG VTB Holdings, LLC, Juergen Stark and Kenneth Fox (collectively “Respondents” and together with Appellant, the “Parties”), by and through their respective counsel of record, that the three consolidated appeals arising from the same underlying action (Supreme Court Case No. 83598, the “First Appeal” or the “Merits Appeal”; Supreme Court Case No. 84971, the “Second Appeal” or the “Fees Appeal”; and Supreme Court Case No. 85358, the “Third Appeal” or the “Costs Appeal”) (collectively the “Pending Appeals”) be set on the following briefing schedule:

- Plaintiff-Appellant’s Opening Brief on the Merits Appeal and Costs Appeal will be due on or before January 12, 2023 and will not exceed 18,500 words;¹
- Defendants-Appellees’ Answering Brief on the Merits Appeal and Costs Appeal and Opening Brief on the Fees Appeal will be

consolidated into a single brief due on March 13, 2023 and will not exceed 18,500 words;

- Plaintiff-Appellant's Reply Brief on the Merits Appeal and Costs Appeal and Answering Brief on the Fees Appeal will be consolidated into a single brief due on or before April 27, 2023 and will not exceed 14,000 words;
- Defendants-Appellees' Reply Brief on the Fees Appeal will be due on or before May 30, 2023 and will not exceed 9,250 words.
