

ORDER GRANTING MOTIONS

PAMTP, LLC has filed a motion to associate New York attorney Jordan L. Pietzsch of the law firm of Holwell Shuster & Goldberg LLP, in this matter pursuant to SCR 42. Attached to the motion to associate Mr. Pietzsch is a verified application, a certificate of good standing from the Appellate Division of the Supreme Court of the State of New York, and a Supreme Court Rule 42 statement. The Rule 42 statement of the State Bar of Nevada indicates that Mr. Pietzsch has not applied to appear in Nevada courts in the last three years. *See* SCR 42(6) (repeated appearances by any person or firm pursuant to this rule shall be cause for denial of a motion).

The motion is granted. Mr. Pietzsch shall be permitted to appear on behalf of PAMTP, LLC in this appeal. Nevada attorney Jeffrey A. Silvestri, of the law firm of McDonald Carano LLP, shall be responsible for all matters presented by Mr. Pietzsch in this matter. *See* SCR 42(14) (the active member of the State Bar of Nevada who is attorney of record shall be present at all matters in open court); NRAP 25(a)(5) (all documents submitted to the supreme court for filing by a represented party shall include the original signature of at least one attorney of record who is an active member of the State Bar of Nevada).

PAMTP, LLC has also filed a motion for leave to file a combined opening brief in Docket Nos. 83598 and 85358 that exceeds the permissible type-volume limitation. *See* NRAP 32(a)(7)(A)(ii). The certificate of compliance attached to the proposed brief certifies that it contains 17,965 words. The motion is granted. NRAP 32(a)(7)(D). The clerk shall detach the combined opening brief from the motion filed on January 12, 2023, and file it separately. Kenneth F. Potashner; VTB Holdings, Inc.; Stripes Group,

LLC; SG VTB Holdings, LLC; Juergen Stark; and Kenneth Fox shall have 30 days from the date of this order to file and serve a combined answering brief in Docket No. 83598, answering brief in Docket No. 85358, and opening brief in Docket No. 84971. Failure to timely file and serve the combined answering and opening brief may result in the imposition of sanctions. NRAP 31(d).

It is so ORDERED.
