1. I am an attorney duly licensed to practice law in the State of Nevada and the Deputy Public Defender assigned to represent B W-A., on appeal currently pending before this Court.

2. The Clark County Public Defender's office was appointed to represent the above named juvenile on October 5, 2021.

3. On October 6, 2021, the Clark County Public Defender's office filed the Notice of Appeal.

4. Upon further investigation into the lower court record, declarant discovered that the Clark County Public Defender's Office has previously represented Byron's stepmother, Hyacinth Worthey, in case 08F07243B where she was charged with Child Abuse or Neglect against Byron.
