## MEMORANDUM

I, RONNI N. BOSKOVICH, ESQ, am a duly licensed attorney in the State of Nevada, and I am the attorney of record for Petitioner James Robert Bonetti in the above-entitled case.

Petitioner Bonetti filed his Petition for Writ of Mandamus/Prohibition on October 15, 2021. Respondent District Court Judge Kimberly Wanker filed her Answer to Mr. Bonetti's Petition on May 2, 2022. Although not required, Petitioner Bonetti will be filing a brief Reply with this Court.

Petitioner's Reply is currently due on June 6, 2022. Petitioner herein makes his first written request for an enlargement of time of fourteen (14) days to June 20, 2022, within which to file his Reply and any additional supporting documentation. This Court may extend the time to file the Reply upon a clear showing of good cause.

Petitioner's writ arises from a case dating back to 2018, with thousands of pages of documental review required to thoroughly understand the issues that are contained within this matter.

Additionally, Counsel needs additional time to review these pleadings with Petitioner Bonetti. Although not required, Petitioner wants the opportunity to file a Reply and address Respondent's Answer appropriately. Petitioner Bonetti is out of custody; therefore, he will not suffer any prejudice by the Court granting this extension. This Motion is made in good faith and not for the purpose of delay.

An additional fourteen (14) days would be ample time to finalize the Reply and ensure that all points are thoroughly addressed.

Therefore, I respectfully request this Court to grant the Motion for Enlargement of Time.
