Any person applying for a name change who has been convicted of a felony must get fingerprinted and submit those fingerprints to the Court with the name change form. If the name change is granted, the court will submit a copy of the name change order to the Central Repository for Nevada Records of Criminal History for inclusion in the applicant's criminal record.

Mr. Robinson did not include a copy of his fingerprints with the rest of his paperwork. The Department of Public Safety website, found at dps.nv.gov, can provide further direction on how to get fingerprinted as required by Nevada law.
