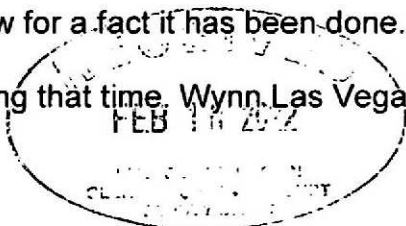


HEARING TIME:
