him and his counsel whether an appeal is allowed."<sup>1</sup> Important for the purposes of this 1 2 motion, the Determination Motion references only **one** order on appeal. 3 This Court issued an Order on December 17, 2021 which held that the Order 4 appointing Mr. Cassady is not appealable pursuant to NRS 140.020(3)(b), but that a 5 second order is appealable: 6 This appeal arises from a dispute as to who should be appointed the 7 administrator of the estate of Demetrios A. Dalacas for purposes of ongoing 8 litigation against the estate. Appellant is a creditor of the subject estate and claimed a statutory right under NRS 139.040 to select the administrator. The 9 district court also entertained a nomination by the estates insurance company and ultimately **entered a formal order** appointing the insurance company's 10 nominee, Jasen Cassady, as special administrator pursuant to NRS 140.020 on September 21, 2021. A separate order issuing "Letters of Special 11 Administration" in favor of Cassady was entered on September 27, 2021.<sup>2</sup> 12 The purpose of this Motion is to seek clarification as to what orders this Court is 13 referencing. The December 17 Order, quoted above, refers to two orders, one September 14 21, 2021(hereafter "September 21 Order") and another on September 27, 2021 (hereafter 15 "September 27 Order"). Attached hereto as Exhibit "1" is the Register of Actions from 16 17 the District Court. The only document entered into the register on September 21, 2021 18 is the Order Affirming Probate Commissioner's Report and Recommendation, 19 Appointing Jasen Cassady as Special Administrator (DocID #51) which is the 20 September 21 Order. The September 21 Order, attached hereto as Exhibit "2", 21 affirmed the recommendations of the Probate Commissioner and appointed Jasen 22 Cassady as Special Administrator. 23 24 As directed by the District Court, the Clerk of the Court issued Letters of Special 25 Administration (DocID #58, hereafter "Special Letters") to Jasen Cassady on September 26 27, 2021 (attached hereto as **Exhibit "3"**). shows that <u>no order was issued on September 27, 2021</u> or any date after September 21. The only document on the Register of Actions for September 27, 2021 is the Special Letters.

### LEGAL ARGUMENT

The Special Letters cannot be the September 27 Order that the Court referred to in it's December 17 Order because the Special Letters aren't an order. Rather, as discussed below, the Special Letters are a document issued by the Clerk of the Court pursuant to the September 21 Order, quoted above. For this reason, Mr. Cassady seeks clarification of the Court.

# 1. The Special Letters Cannot be an Order Because the Clerk of the Court Has No Authority to Appoint a Special Administrator

The Special Letters cannot be the September 27 Order because under Nevada probate law, the Court appoints a Special Administrator, not the Clerk of the Court. The Clerk merely issues the letters. The Clerk of the Court has no authority to appoint an administrator and thus letters issued by the Clerk cannot be appealed.

"The court shall appoint a special administrator to collect and take charge of the estate of the decedent..."<sup>3</sup> Thus, it is the Court that appoints a Special Administrator.
Upon the appointment by the Court, the Clerk issues letters. NRS 140.020(2) directs that "[u[pon the filing of the order, and after the person appointed has given bond if fixed by the court, the clerk shall issue special letters of administration, with a copy of the order attached." Emphasis added.

That is what has happened in this matter. The September 21 Order appointed Mr. Cassady. "IT IS FURTHER ORDERED, ADJUDGED AND DECREED that JASEN

CASSADY, is appointed as Special Administrator of the Estate of DEMETRIOUS DALACAS to act on behalf of the Estate in pending litigation where the Decedent or the Estate is named as a party, and that Letters of Special Administration be issued to him upon him taking the oath required by law."4

The Clerk of the Court then acted on the instructions in the September 21 Order and issued the Special Letters. "On the 21st of September 2021, the Court entered an Order appointing Jasen Cassady as Special Administrator of the estate of the abovenamed Decedent." "The Special Administrator having duly qualified may act and has the authority and duties of a Special Administrator as provided under NRS 140.040."5

In the process of appointing a Special Administrator, there is only one order entered—by the Court. The Clerk of the Court then acts on the order and issues the letters. Accordingly, the Special Letters cannot be the September 27 Order this Court references in the December 17 Order.

# 2. The Special Letters Cannot be an Order Because Issuance of Letters Is a Ministerial Act.

NRS 3.250-305 enumerates the powers of the Clerk of the Court in District Court. Those enumerated powers do not include any discretion as to issuing orders appointing special administrators.

As noted immediately above, the Court issues an order appointing an administrator and the Clerk of the Court obeys and follows the direction of that order.6 Thus, when the Clerk of the Court issues letters, it is merely a ministerial act and not an

order of the Court. "A ministerial act is an act performed by an individual in a prescribed legal manner in accordance with the law, without regard to, or the exercise of, the judgment of the individual."7 As such, there cannot be abuse of discretion or clear error for this Court to review as the Clerk of the Court is merely acting at the direction of the District Court judge who signs the order.

# 3. The Special Letters Cannot be the September 27 Order Because the Notice of Appeal Only References the September 21 Order

NRAP 4(a)(1) provides that, "...a notice of appeal must be filed after entry of a written judgment or order, and no later than 30 days after the date that written notice of entry of the judgment or order appealed from is served."

The Notice of Appeal (Exhibit "4") only identifies one order on appeal—the September 21 Order: "Notice is hereby given that Creditor, RYAN MCCLARAN, hereby

appeals to the Supreme Court of Nevada from the Order Affirming Report and

Recommendation Appointing Jasen Cassady as Special Administrator entered in this

case on September 21, 2021 with Notice of Entry being filed September 22, 2021 and the

Letters of Special Administration filed on September 27, 2021."

Although the Notice of Entry is referenced in the Notice of Appeal, it is not

subject of an appeal itself, nor are the Letters.

4. A September 21 Order which is appealable, and a September 27 Order which is not, creates the possibility of a contradictory outcome.

The Special Letters cannot be the September 27 Order referenced by this Court's December 17 Order because if they were, it would potentially result in a contradictory outcome. The December 17 Order held that the September 21 Order is not appealable pursuant to NRS 140.020(3), but that the September 27 Order is not.

This September 21 Order appointed Mr. Cassady. This Court has ruled, correctly, that the September 21 Order is not appealable as it lacks jurisdiction. The Special Letters cannot be the September 27 Order because they only act on the September 21 Order. More specifically, the only act the Special Letters take is the ministerial act appointment of Mr. Cassady as Special Administrator as directed by the non-appealable September 21 Order. This Court has already ruled that the appointment of Mr. Cassady as Special Administrator is not appealable pursuant to NRS 140.020(3). Thus, even if the Special Letters were an appealable order—which they are not—there is no issue referenced within the Special Letters for this Court to review or decide.

### CONCLUSION

Mr. Cassady seeks clarification from this Court as to it's December 17 order.
Specifically, what is the second order, dated September 27, 2021 that is referenced?
How can there be a second order on appeal where the Notice of Appeal references only one order? The Special Letters cannot be the September 27 Order because the Clerk of the Court does not have authority to issue orders appointing special administrators.

19 Creditor Ryan McClaran's (hereafter "Creditor" or "McClaran") Objection to Probate 20 Commissioner's Report and Recommendation and Motion for Evidentiary Hearing Doc ID #35 (hereafter "Objection") came before the Court on July 22, 2021, and following the review of the 22 papers and pleadings on file, and considering oral argument by counsel at the time of hearing, the 23 Court issued a Minute Order, now reduced to a formal order, which hereby finds and orders as 24 follows:

25 THE COURT FINDS AND CONCLUDES that although the parties disagree as to the 26 applicable standard of review of the objection the Probate Commissioner's Report and 27 Recommendation Doc ID #30 (hereafter "RAR"), dated May 25, 2021, the case law under Venetian 28 Casino, suggests that the correct standard is de novo review for questions of law and abuse of

discretion for question of fact. Thus, the report and recommendations must be reviewed for clear error or arbitrary or capricious abuse of discretion. Qualification of an administrator is a question of 2 fact. Here, the court is unable to discern a clear error or arbitrary or capricious abuse of discretion. 3 Venetian Casino Resort, LLC v. Eighth Jud. Thus, there is no factual basis to sustain the Objection. District. Ct., 41 P.3d 327, 332 (2002). 4

THE COURT FURTHER FINDS AND CONCLUDES that parties agree to the relevant statute: NRS139.010 and 130.040. There is no dispute that under NRS 139.040(1)(h) and (j), McClaran, a purported creditor, enjoys a priority in appointment over Lipson Neilson. However, the Probate Commissioner, in the RAR, made a ruling clearly finding of conflict of interest by attorney Sharp, who as nominated by McClaran, under NRS 139.010. Thus, under NRS 139.010(3), Sharp is not qualified to serve as the administrator and the priority for right to appointment need not even be discussed.

THE COURT FURTHER FINDS AND CONCLUDES that Dickerson v. Eighth Judicial Dist. Court, 82 Nev. 234, 238, 414 P.2d 946, 949 (1966) is inapplicable here. It is noted that Dickerson was issued in 1966 and NRS 130.010 was amended multiple times since then. Most notably, in 2001, this statute was amended to specifically include conflict of interest as basis to find that a person is qualified to serve as an administrator. Thus, Dickerson was overruled by Statute. Furthermore, applying Dickerson to this case would negate the power of the court to appoint a special administrator under NRS 140.020.

THE COURT FURTHER FINDS AND CONCLUDES that there is insufficient argument that attorney Cassady is not qualified to act as the special administrator or that he has a conflict of interest. Thus, under NRS 139.050, his nomination to serve as the administrator should be granted.

Therefore, based upon the foregoing, and good cause appearing,
