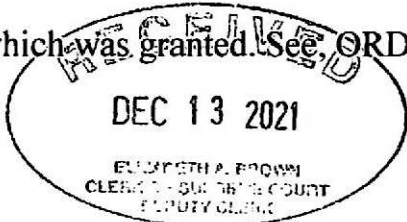

24 **Brief Procedural History:** Appellant had called to get an extension for

1 Appellant had misplaced his envelope to send in his docketing
2 statement including orders attached to the docketing statement and appellant
3 usually uses a third party process service company to file his documents into the
4 Nevada Supreme Court which such service does not operate on the weekends. The
5 docketing statement was originally due on 12/10/2021, which fell on Friday and
6 even if Shahrokhi had placed his docketing statement in the usps, date stamped on
7 the 10th, the 3-days mailing grace period would have landed the documents in the
8 court's possession today Monday 12/13/2021.

12 As such the clerk of the court would have filed the docketing statement
13 either on 12/13/2021(today) or on or around 12/14/2021.
