## **MEMORANDUM**

I, JOHN AFSHAR, am a duly licensed attorney in the State of Nevada and am employed by the Clark County District Attorney's Office. I am the supervising attorney in the above-captioned case. Real Party In Interest's Answer to Lepolo's Petition for Writ of Mandamus is currently due on Thursday, January 20, 2022. The State requests a thirty-day (30) extension of time in which to file its Answer. NRAP 31(b)(3).

This is the State's first request for an enlargement of time. If granted, the new filing date for Real Party In Interest's Answer would be due on or before Monday, February 21, 2022.
