**MOTION TO EXTEND TIME TO FILE ANSWERING BRIEF**

Respondent, The Regional Transportation Commission of Washoe County (“RTC”), through its counsel, Woodburn and Wedge, moves this Court pursuant to NRAP 26(b) and NRAP 31(b)(3) for an order extending the time within which RTC must file its answering brief.

RTC's answering brief is currently due on January 31, 2022. RTC requests an additional thirty (30) days beyond that date within which to file its answering brief, up to and including March 2, 2022. This is the first request for an extension of time to file RTC's answering brief. As no prior requests have been made, none have been denied. RTC requests this extension of time because the schedule of RTC's counsel is such that additional time is necessary to allow for proper preparation of the answering brief. This includes multiple depositions at the end of January and early February, as well as another brief due currently due in this Court at or about the same time.

For the foregoing reasons, RTC respectfully requests that the Court grant an additional 30 days, up to and including **March 2, 2022**, within which RTC may file and serve its answering brief.

RTC's counsel has conferred with Appellants' counsel, and Appellants' counsel does not oppose RTC's request for additional time to file the answering brief. See Exhibit 1, attached.
