
On December 23, 2021, this Court entered an Order for Real Party in Interest to, within 28 days, file and serve and answer to address the propriety of writ relief and the merits of the petition. Counsel for the parties have during that time been engaged in settlement discussions to resolve this matter, and are still engaged in such

discussions. Additionally, Counsel for Real Party in Interest is a solo practitioner and has had other time sensitive matters and pre-existing commitments which has hindered his ability to adequately respond to the Petition.


Counsel estimates that an additional 60 days may be necessary to either resolve the matter or draft the appropriate answer to the Petition.
