MOTION TO EXTEND TIME

COMES NOW Real Party in Interest, Alexander Marks, by and through his attorney of record, Jeffrey Gronich, Attorney at Law, P.C., and hereby files this Motion to Extend Time for him to file and serve and answer to the Writ of Mandamus. This is the second request for extension for this action, however, good cause exists to warrant the extension.

On December 23, 2021, this Court entered an Order for Real Party in Interest to, within 28 days, file and serve and answer to address the propriety of writ relief and the merits of the petition. On January 28, 2022, this Court granted a stipulation

by the Parties to extend that deadline to March 22, 2022. During that period, the Parties have been engaged in settlement discussions and have come to a resolution in principle. The Parties are still negotiating specific language for a settlement agreement which would resolve this matter and cause this Writ of Mandamus to become moot.

Therefore, rather than unnecessarily waste the Court's time and attention to this issue, Real Party in Interest requests an extension of forty-five days, through May 6, 2022, to either finalize the settlement agreement and stipulate for a dismissal of this matter, or to file his Answer to the Writ of Mandamus.
