These appeals shall be consolidated for all appellate purposes. *Id.* A copy of the first page of appellant's notices of appeal are attached to this order.

Appellant has filed his informal brief in Docket No. 83774. The exhibits attached to the brief were returned, unfiled. NRAP 30(i) ("A pro se party shall not file an appendix except as otherwise provided in these Rules or ordered by the court."). Appellant's opening brief or informal brief in 83773 and 83841 is due to be filed on or before April 12, 2022, and the opening brief or informal brief in 83952 and 83956 is due to be filed on or before May 10, 2022.
