

On August 6, 2021, Defendant, NICHOLAS CHARLES LANZALACA (Date of Birth: August 29, 1990; Place of Birth: Salt Lake City, UT) entered a plea of guilty to the crime of COUNT 1: ATTEMPTED POSSESSION OF A CONTROLLED SUBSTANCE, A CATEGORY E FELONY OR A GROSS MISDEMEANOR AS DEFINED BY NRS 453.336 AND NRS 193.330 (NOC 62074) which crime occurred on or about April 28, 2021, and sentenced Defendant on October 8, 2021, as follows:

IT IS HEREBY ORDERED that the aforementioned charge is adjudicated as a Category E Felony.

IT IS FURTHER ORDERED that Defendant shall pay an administrative assessment fee of \$25.00 pursuant to NRS 176.062.

IT IS FURTHER ORDERED that Defendant shall pay a DNA administrative assessment fee of \$3.00 pursuant to NRS 176.0623.

IT IS FURTHER ORDERED that Defendant shall pay \$60.00 fee for the analysis of the controlled substance pursuant to NRS 453.575.

IT IS FURTHER ORDERED that the Defendant shall pay a \$150.00 fee for purposes of obtaining a biological specimen from the Defendant and for performing genetic marker analysis of said specimen pursuant to NRS 176.0915.

IT IS FURTHER ORDERED that for Count 1, Defendant is ordered to serve a sentence of 12 to 30 months in the Nevada Department of Corrections. Defendant has credit for 16 hours previously served, as of October 8, 2021.

- 4. Defendant shall not gamble. Further, Defendant shall not be present in casinos or any other establishment whose primary purpose is gambling, unless required by, and in the scope of, actual employment.
- 5. Defendant shall submit her digital storage media and any digital storage devices to which she has access to or uses, including

computers and handheld devices, and any network applications associated with those devices (including social media and remote storage services), to a search, and shall provide all associated passwords, unlock codes and account information, with or without a search warrant, to the Division of Parole and Probation or its designated agent.

IT IS FURTHER ORDERED that Defendant shall report to the Division of Parole and Probation for intake no later than close of business on October 8, 2021, or as directed by the Division of Parole and Probation.

### <u>ARRAIGNMENT – GUILTY PLEA AGREEMENT</u>

Court convened at 11:23 a.m.

The Court noted the presence of the parties.

This was the date and time set for an arraignment on the Criminal Information filed charging COUNT 1: ATTEMPTED POSSESSION OF A SCHEDULE I OR II CONTROLLED SUBSTANCE, A CATEGORY E FELONY OR A GROSS MISDEMEANOR IN VIOLATION OF NRS 453.336. AND NRS 193.330.

A certified copy of the Criminal Information was presented to the Defendant.

The Defendant advised that he reviewed the Criminal Information with his attorney and was satisfied with legal representation to date.

The name of the Defendant was correctly stated.

Defense counsel waived the formal reading of the Criminal Information.

The Court read the charging portion of the Criminal Information and asked the Defendant to enter a plea.

The Defendant entered a plea of guilty to the charge.

The Court canvassed the Defendant regarding his personal information.

The Court noted that a 9-page Memorandum of Plea Agreement was filed August 5, 2021 and canvassed the Defendant concerning the agreement.

The Court canvassed the Defendant regarding the elements of the crime, the potential defenses, and his constitutional rights.

Defense counsel placed the terms of the Plea Agreement on the record. All parties concurred.

The State cited the elements of the crime and the potential penalties involved.

The Court advised the Defendant that sentencing was wholly within the discretion of the Court.

The Court reviewed the Defendant's Constitutional Rights, and the Defendant waived the same.

The Defendant presented an explanation of the crime alleged in the Criminal Information.

The Court found that the Defendant's plea was offered voluntarily, knowledgeably, and intelligently, with full knowledge of his Constitutional Rights, and there was a factual basis for the plea, and the Defendant understood the consequences of his plea.

The Court **ORDERED** a Presentence Investigation Report due on or before September 24, 2021. Sentencing was set for October 8, 2021, at 10:30 a.m.

The Court instructed the Defendant to cooperate with the Division in the preparation of the presentence investigation report.

Court adjourned at 11:37 a.m.

### SENTENCING HEARING

All parties advised they were in receipt of the Presentence Investigation Report.

The State did not make any corrections to the report.

Defense counsel made corrections to the report.

No objections by the State or Parties to making correction via interlineation.

The Court advised the Defendant had credit for 16 hours previously served.

The State presented its position for sentencing.

Defense counsel presented a recommendation on behalf of the Defendant.

The Court advised the Defendant of his right to make a statement on his own behalf.

After being canvassed by the Court, both parties advised that there was no cause why formal judgment should not be entered at this time.

The Court **ORDERED** a Judgment of Conviction be entered against the Defendant finding the Defendant guilty of COUNT 1: ATTEMPTED POSSESSION OF A SCHEDULE I OR II CONTROLLED SUBSTANCE, A CATEGORY E FELONY.

The matter being submitted;

The Court **ORDERED** the Defendant to pay a \$25.00 administrative assessment fee, \$3.00 genetic administrative assessment fee, \$60.00 chemical analysis fee, \$150.00 genetic testing fee, submit to testing to determine his genetic markers, and be sentenced to serve a maximum of 30 months in the Nevada Department of Corrections with minimum parole eligibility after 12 months with credit for 16 hours previously served. Said sentence was suspended and the Defendant was placed on probation for 18 months under the standard terms and conditions of probation with the following special conditions:

- 1. The Defendant to abstain from the use of alcohol or being present in any establishment that serves alcohol unless required to be so present for employment.
- 2. The Defendant to abstain from gambling or being present in any gaming establishment unless required to be so present for employment.
- 3. The Defendant to abstain from the use of marijuana and marijuana products.
- 4. The Defendant to obtain a substance abuse evaluation within 30 days and if deemed necessary by the Division enter and complete a program at his own expense.
- 5. The Defendant to submit all digital media storage devices to the Division of Parole and Probation with or without a search warrant.
- 6. The Defendant shall contact Parole and Probation by the close of business on October 8, 2021.

The Court **ORDERED** the previously posted bail bond be exonerated.
