Real Party in Interest St. Paul Fire & Marine Insurance Company ("St. Paul"), respectfully moves this Court for an extension of time for a period of 60 days from the current due date within which to file its answer to the Writ Petition filed by Aspen Specialty Insurance Company ("Aspen"). The answer is currently

due on January 18, 2022. This extension of time would make the answer due on or before March 21, 2022 (as March 19, 2022 falls on a Saturday). This is St. Paul's first request for an extension of time.

On July 20, 2021, appellate counsel for St. Paul, Michael K. Wall, of Hutchison & Steffen passed away after his short battle with COVID-19. Mr. Wall served as St. Paul's lead appellate counsel in this case involving National Union and Aspen. Following Mr. Wall's passing, his law partner, Daniel Stewart, assumed responsibilities for appellate briefing in St. Paul's pending appeal involving National Union as well as this case. However, Mr. Stewart has been asked by Governor Sisolak to serve as a member of his senior staff, and Mr. Stewart begins that service in the Governor's Office beginning January 10, 2022.

Additionally, Aspen's Writ Petition is over 10,000 words and raises complex issues that will take additional time to respond to, including the propriety of writ relief itself.

Given all of the above (as well as the recent Holidays), St. Paul respectfully requests additional time to complete the complex task of briefing and submitting an answer by January 18, 2022. Specifically, St. Paul requests 60 days to March 21. 2022. This request is presented in good faith, and not for purposes of delay or any other improper reason. Counsel for St. Paul has also discussed the extension request with counsel for Aspen. Counsel for Aspen has agreed to the request, and

St. Paul has agreed to consent to an extension for Aspen's Reply, should Aspen request one at a later date.
