- 1. I am employed by the Nevada Department of Corrections (NDOC) as the Acting Chief of Purchasing & Inmate Services Chief.
- 2. As part of my duties, I oversee and assist in the maintenance of inmate trust records.
- 3. Inmates do not utilize cash within the prison system. To mail an envelope, an inmate may affix their own stamp, or may utilize a "brass slip," a procedure by which the inmate requests postage for a designated purpose and for a specific dollar amount. Brass slip requests are entered in the inmate's trust account records and maintained by NDOC Inmate Banking Services.

- 4. At the request of the Attorney General's Office, I obtained and reviewed the Primary Trust Transactions for High Desert State Prison, where Inmate Marcos Ramos Hernandez, NDOC # 1249611, is housed, for the period of October and November 2021.
- 5. Attached as Exhibit "A" is a copy of that account. There is no entry for Inmate Marcos Ramos Hernandez, NDOC # 1249611, for postage during this period of time.
