**STIPULATION TO EXTEND TIME FOR REAL PARTY IN

NEASON, TO FILE AND SERVE ANSWER**

IT IS HEREBY STIPULATED AND AGREED by and between Petitioners  
Casiano Flaviano, MD and Sushil R. Patel, MD, Real Party in Interest Arlis  
Neason, as Heir of the Estate of Jeffrey Neason, and Real Party In Interest Dignity

Select Nevada, LLC, erroneously named Dignity Health Medical Group Nevada, LLC, by and through their below referenced attorneys, as follows:

Petitioner Casiano Flaviano, MD filed a Writ of Mandamus on November 22, 2021. The Writ concerns the sufficiency of a medical malpractice NRS 41A affidavit.

Petitioner Sushil R. Patel, MD, filed a Joinder to the Writ on November 24, 2021. The Court granted the Joinder as a Motion on December 7, 2021.

The Court issued an Order directing Real Parties In Interest to file an Answer within 21 days on December 14, 2021, making an Answer by Real Parties in Interest due January 4, 2022.

Real Party in Interest Arlis Neason, as Heir of the Estate of Jeffrey Neason, called and obtained a telephonic extension through January 25, 2022 to file an Answer, entered by the Court on January 5, 2022.

Real Party In Interest Dignity Select Nevada, LLC, erroneously named Dignity Health Medical Group Nevada, LLC, filed a “Joinder to Petitioners Sushil R. Patel M.D.’s and Casiano Flaviano’s M.D.’s Petition for Writ of Mandamus And Answer In Support of Petition on January 11, 2022.”

The Parties hereby stipulate, agree, and do not oppose, an extension for Real Party In Interest Arlis Neason, as Heir of the Estate of Jeffrey Neason, as follows:

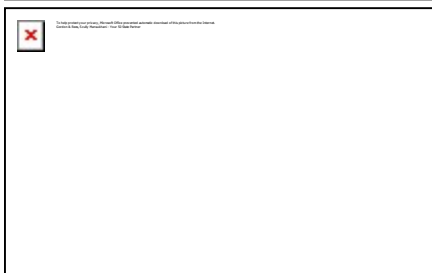

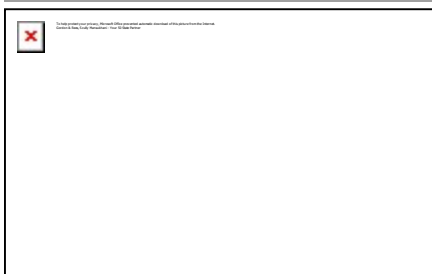

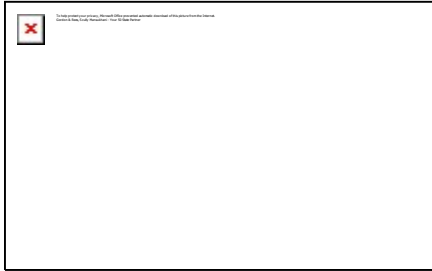
