Upon review, Appellants have concluded that the Court is correct that Chef Exec is not an appropriate appellant of the attorneys fee award, as that award was solely against Appellant Clement Muney.

Appellants agree and consent to the dismissal of Chef Exec as an appellant in Appeal 83869.

Appellants with to note however that Appellant Clement Muney's standing to appeal is unaffected by these facts, and also that there is a pending motion to consolidate Appeal 83869 and Appeal 83641. As Chef Exec is an appellant (with undisputed standing) in Appeal 83641, if the Court is inclined to grant to motion to consolidate, then the question of Chef Exec's standing to appeal may become moot (or at least only apply to one issue within the appeal, rather than the entire appeal).

## II. CONCLUSION

Appellants consent to dismissal of Chef Exec as an Appellant in Appeal 83869, although Appellants suggest that the matter would be equally resolved by the granting of Appellants' motion to consolidate Appeals 83641 and 83869 (with the understanding that Chef Exec would not be party to the claim against the attorneys fees award).
