

ORDER

Rachel Chaisson of Transcript Video Services has filed a motion for a second extension of time to prepare and file certain transcripts. Once a movant receives a telephonic extension of time to perform an act, further extensions of time to perform that same act are barred unless the movant files a motion for an extension of time demonstrating extraordinary and compelling circumstances in support of the requested extension. NRAP 26(b)(1)(B). It appears that Transcript Video Services previously received a telephonic extension of time to file the requested transcripts.¹ And Transcript Video Services does not demonstrate extraordinary and compelling circumstances warranting a second extension of time. Nevertheless, because it appears that an extension is necessary, the motion


¹The order granting the telephonic extension granted an extension of time to court reporter Sherry Justice. It does not appear that there is a licensed court reporter named Sherry Justice in the state of Nevada. It also appears, however, that Sherry Justice is associated with Transcript Video Services.

is granted to the following extent.² Transcript Video Services shall have until April 11, 2022, to file the requested transcripts in the district court, deliver copies to the requesting party, and file a notice with this court that the completed transcripts have been filed and delivered. See NRAP 9(c)(1)(A), (2). Failure to timely prepare, file, and deliver the requested transcripts may result in the imposition of sanctions. NRAP 9(c)(5); NRAP 13(b).

This court notes that while the extension motion states that it requests an extension of time to prepare the transcripts of proceedings occurring on June 8, 2021, and January 27, 2022, the transcript request form filed in this court requests the production of transcripts of the proceedings occurring on March 12, 2021, June 8, 2021, and August 12, 2021. Accordingly, within 7 days of the date of this order, Transcript Video Services shall confer with counsel for appellant and confirm the dates of the proceedings to be transcribed.

Given the extension of time to prepare and file transcripts, the time to file the opening brief and appendix is extended as follows. Appellant shall have until June 9, 2022, to file and serve the opening brief and appendix. Failure to timely file and serve the opening brief and appendix may result in the imposition of sanctions. NRAP 31(d).

It is so ORDERED.
