**MOTION FOR EXTENSION OF TIME TO FILE APPELLANT'S  
REPLY TO RESPONDENTS' OPPOSITION TO MOTION TO STRIKE  
PORTIONS OF RESPONDENTS' APPENDIX**

Kathleen June Jones ("June" or "Appellant"), Appellant, by and through counsel, Scott Cardenas, Esq. and Elizabeth Mikesell, Esq., of Legal Aid Center Of Southern Nevada, Inc., respectfully move this Court, pursuant to NRAP 26(b)(1) for an extension of 7 days to file her Reply to Respondents' Opposition to Motion to Strike Portions of Respondents' Appendix.

Appellant's reply was originally due November 28, 2022, which is 7 days after Respondents' filed their Opposition to Motion to Strike Portions of Respondents' Appendix on November 21, 2022. This is

Appellant's first motion for extension of time. No request for additional time has been denied or denied in part.
