**MOTION FOR EXTENSION OF TIME TO FILE
RESPONDENTS' RENEWED MOTION TO FILE DOCUMENTS
IN APPENDIX VOLUME 8 UNDER SEAL
(First Request)**

Respondents, Robyn Friedman and Donna Simmons, respectfully move this Court, pursuant to NRAP 26(b)(1)(A) for an extension of two weeks in which to file their renewed motion to file documents in appendix volume 8 under seal.

Respondents' renewed motion was originally due on December 12, 2022. This is Respondents' first motion for extension of time. No request for additional time has been denied or denied in part. If this Court grants this request for an extension of two weeks, Respondents' renewed motion will be due Tuesday, December 27, 2022.

Good cause exists to grant the requested extension for the following reasons:

1. On December 5, 2022, this Court entered an order regarding Respondents' motion to file documents under seal in which the Court granted the motion to the extent of all portions of Respondents' appendix received on October 27, 2002, except volume 8. The order also allowed Respondents to file a renewed motion to file the documents within volume 8 under seal within 7 days of the date of the order.

2. Appellate counsel is awaiting instruction from co-counsel on how they want to proceed regarding this Court's December 5, 2022 order denying motion to seal with respect to documents within volume 8 of Respondents' appendix. As the Court noted, the documents in volume 8 were not filed under seal in the District Court. But, some of the documents contain confidential information that should be placed under seal in both the District Court and this Court. But, Respondents did not file the confidential documents in the District Court.

3. The additional two weeks will allow appellate counsel to receive instruction from co-counsel and will allow sufficient time for

counsel to file the documents in volume 8 under seal in the District Court, as well.

For the foregoing reasons, Respondents respectfully request a two-week extension of time, until December 27, 2022, within which to file their renewed motion to file documents in appendix volume 8 under seal. This motion is submitted in good faith and for good cause shown in accordance with NRAP 31(b)(3).
