**JOINT MOTION TO EXTEND
TIME FOR RESPONDENT
RUSSELL ROAD FOOD &
BEVERAGE, LLC'S REPLY
TO APPELLANTS RESPONSE
TO ORDER TO SHOW
CAUSE**

Respondent, RUSSELL ROAD FOOD AND BEVERAGE, LLC (“Russell Road”) by and through its counsel of record, Jeffery A. Bendavid, Esq. and Stephanie J. Smith, Esq. of Bendavid Law, and RHONDA ROE, DENISE DOE, JANE DOE DANCER, AND JANE DOE DANCERS 2-7 (“Appellants”), by and through their counsel Leon Greenberg, Esq. of Leon Greenberg P.C. hereby jointly move the Court, pursuant to NRAP 26(b)(1)(B) to extend the time for Russell Road’s Reply to Appellants’ Response to Order to Show Cause.

The Appellants and Respondents have been engaged in settlement negotiations and believe they have reached a settlement. However, since the settlement involves multiple individual Appellants, and multiple Respondents the Parties need additional time to finalize and effectuate terms. Good cause exists since parties anticipate that they will be able to resolve the matter, thereby preserving judicial economy, and additionally saving all parties additional attorneys’ fees.
