POINTS AND AUTHORITIES

This honorable court filed an Order Dismissing Appeal on January 25, 2022. The dismissal was based upon Appellants' failure to comply with a Notice of Potential Dismissal For Failure to Pay Supreme Court Filing Fee (hereinafter "Notice") filed on January 10, 2022. The Notice directed Appellants to either remit the filing fee or demonstrate compliance with NRAP 24. Despite good faith efforts to ensure compliance by undersigned counsel for Appellants, he mistakenly relied on incorrect information and failed to properly ensure compliance. (See Affidavit, attached hereto as Exhibit A.)

A party may bring a motion for reconsideration under NRAP 27(3) in relation to this Order. In this case, counsel had signed a Cost Advance Request on January 4, 2022, requesting \$500.00 for "filing for appeal to supreme court." (Exhibit B.) Counsel mistakenly believed the check was for the filing fees to this court, as indicated on the request. (*Id.*) Upon receipt of the Notice on January 10, 2022, counsel confirmed that the check had been received and sent for filing the week before. (*Id.*) Upon receipt of the Order Dismissing Appeal, counsel confirmed that the check had in fact been sent via Fedex and delivered to the Eighth Judicial District Court on January 7, 2022. (Exhibit C.) Upon further investigation, counsel discovered the \$500.00 check was for a bond filed on January 13, 2022, and that there had been internal miscommunications and misunderstandings regarding the check. (*Id.*) Undersigned counsel has submitted filing fees via this process for that last several months without issue in several cases

1 currently pending before this Court (See Case Nos. 83563, 83686, 83707, 83970,
2 84034, and 84035). (*Id.*) Counsel understands his duty to exercise due diligence and to
3 obey court orders. Although he thought he had done just that, in hindsight he
4 understands he did not.

5
6 This court has repeatedly held that cases are to be heard on the merits if possible.
7
8 Passarelli v. J-Mar Dev., 102 Nev. 283, 285, 720 P.2d 1221, 1223 (1986.). In this case,
9 as soon as it was discovered that the check had in fact not been sent, Appellants
10 immediately filed this motion. This delay of just days does not prejudice Respondent.
11
12 In fact, the District Court Judge has not yet ruled on Appellants' Motion for Stay in this
13 matter. (Exhibit D, showing in chambers hearing, but no having no ruling yet issued.)
14 Moreover, the issue in this appeal is regarding statutory interpretation of NRS
15 617.457(11). Specifically, with regard to the parameters of corrective actions which
16 Nevada police officers (and other statutorily defined professions) must take in order not
17 to be excluded from the conclusive presumption that heart disease is industrially related
18 under the Heart & Lung Bill. This issue affects not only the Respondent, but potentially
19 many others under similar circumstances.

22 In this case, Appellants timely filed their appeal, submitted their bond, and other
23 documents procedurally required to initiate an appeal per NRS 233B, the Nevada
24 Administrative Procedure Act. When the totality of circumstances are considered,
25 counsel hopes the court will see this was an honest mistake made with no intent to
26 delay or avoid paying fees, which Appellants have paid without issue in numerous
27

1 pending cases before this court. Counsel respectfully requests that any sanctions for this
2 failure should be imposed against him, and not the Appellants in this matter.



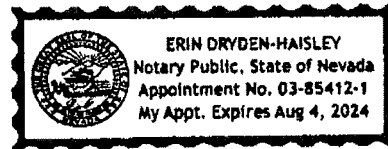
