**SECOND SUPPLEMENTAL STATUS

STIPULATION AND ORDER FOR
DISMISSAL**

Appellants' counsel has filed a Petition for Special Letters of Administration in Probate Court, seeking appointment of a Special Administrator for the Estate of Giann Bianchi. The Petition is pending, and seeks appointment of Petitioner Isolde Parr as Special Administrator.

Though no order appointing special administrator has been entered, Appellants move the Court to substitute Ms. Isolde Parr as the presumptive Special Administrator for the purposes of maintaining Appellant Giann Bianchi's appeal and finalizing settlement. Alternatively, Appellants respectfully request the Court extend the time for the Appellants to file a motion to substitute a special administrator.

Additionally, Appellant Dara Del Priore respectfully requests the Court extend the deadline to file dismissal documents by 180 days, to allow for the completion of the Probate proceedings related to Appellant Giann Bianchi.
