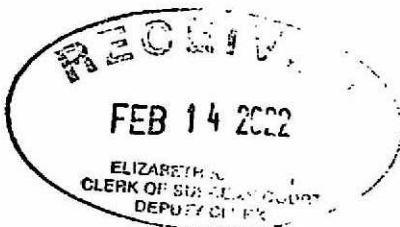

NOTICE OF MOTION
