### **MEMORANDUM OF POINTS AND AUTHORITIES**

Under NRAP 26(b), for good cause, the Court may extend time to perform any act prescribed in the Nevada Rules of Appellate Procedure. On or before the due date sought to be extended, a party may request by telephone a single 14-day extension of time, and if good cause is shown, the clerk may grant such request by telephone. However, for any further extensions of time, the party must file a written motion for an extension of time demonstrating extraordinary and compelling circumstances why a further extension of time is necessary.

Motions for extensions of time are governed by Rule 31(b). Subsection (3) of said Rule states that the motion shall include the following:

(i) The date when the brief is due;

(ii) The number of extensions of time previously granted (including a 14-day telephonic extension), and if extensions were granted, the original date when the brief was due;

(iii) Whether any previous requests for extensions of time have been denied or denied in part;

(iv) The reasons or grounds why an extension is necessary (including demonstrating extraordinary and compelling circumstances under Rule 26(b)(1)(B), if required); and

(v) The length of the extension requested and the date on which the brief would become due.

Per the Court's order, the Fast Track Statement (FTS) and Appendix are

currently due on April 6, 2022. Bradley has never requested a telephone extension.

Bradley has filed one previous motion for an extension by because the transcripts had not yet been prepared. This Court granted Bradley's Motion. This Court has never denied any requests for an extension of time.

Bradley files the instant motion, seeking an extension of two days. The extraordinary and compelling circumstances are as follows: The undersigned's office is currently undergoing construction. This has intermittently affected the office's power, internet router, and network access. The undersigned's office's network and file access, including all document preparation are cloud-based and only accessible with internet access. The undersigned is not privy to any information about the construction company's renovation schedule.

At approximately 5:15 p.m. this evening, when the undersigned and her paralegal were revising and completing Bradley's fast track statement and appendix, the undersigned was informed by her supervising attorney that the office construction company was immediately turning off the internet router and network access off to continue their construction. The undersigned and her paralegal were then unable to access Bradley's file and complete his fast track statement and appendix. Counsel believes that she and her paralegal have also lost a portion of the work that they had done. There is no way to determine this until they have access to the network again on Thursday, April 7, 2022.

Based on the above, Bradley respectfully requests a two-day extension to file

the FTS and Appendix—specifically the FTS and Appendix would be due April 8,

2022. This motion is brought in good faith and not for purposes of delay.
