



1 MEMORANDUM OF POINTS AND AUTHORITIES IN SUPPORT OF
2 MOTION TO SET REASONABLE BAIL

3
4 **STATEMENT OF THE FACTS**

5
6 On April 23rd, 2020, the State of Nevada filed a Criminal
7 Complaint in Las Vegas Justice Court case #20F07961A charging
8 Defendant JAQUAN GAMBOA with one count of Burglary and one count
9 of Invasion of the Home. Please note that both of those charges
10 arose from the same incident at a residence at which no one was
11 home that allegedly took place on January 29th, 2020.

12
13 At the time of the incident, GAMBOA was on parole and the
14 Division of Parole & Probation placed a parole hold on him at
15 the time of his arrest on or about April 21st, 2020.

16 On November 20th, 2020, the State of Nevada filed an
17 Indictment charging Defendant JAQUAN GAMBOA with one count of
18 Burglary and one count of Invasion of the Home. Again, both
19 counts involve the same residence on the same night. At the
20 time of the filing of the Indictment, defendant was in custody
21 at the Nevada Department of Corrections.

22 In August of 2021, GAMBOA expired his aforementioned NDOC
23 sentence and is currently in custody at the Clark County
24 Detention Center on a no bail hold.

25 ///

1 NRS 178.4851(1) expressly provides that upon a showing of
2 good cause, a court may release without bail any person entitled
3 to bail if it appears to the court that it can impose conditions
4 on the person that will adequately protect the health, safety
5 and welfare of the community and ensure that he will appear at
6 all times and places ordered by the court.

7 Further, NRS 178.4853 sets forth the following factors that
8 the Court may consider in deciding whether to release a
9 Defendant without bail:

- 11 1. The length of his residence in the community;
- 12 2. The status and history of his employment;
- 13 3. His relationships with his spouse and children, parents or
14 other members of his family and with his close friends;
- 15 4. His reputation, character and mental condition;
- 16 5. His prior criminal record, including, without limitation,
17 any record of his appearing or failing to appear after
18 release on bail or without bail;
- 19 6. The identity of responsible members of the community who
20 would vouch for the reliability of the person;
- 21 7. The nature of the offense with which he is charged, the
22 apparent probability of conviction and the likely sentence,
23 insofar as these factors relate to the risk of his not
24 appearing;
- 25 8. The nature and seriousness of the danger to the alleged
victim, any other person or the community that would be
posed by the person's release;
9. The likelihood of more criminal activity by him after he is
released; and
10. Any other factors concerning his ties to the community or
bearing on the risk that he may willfully fail to appear.

1 Here, the "Declaration of Anthony M. Goldstein, Esq., in

7 I, ANTHONY M. GOLDSTEIN, ESQ., Attorney at Law, after being
8 duly sworn as an officer of the Court, depose and state as
9 follows:

11 1. I have been a duly licensed attorney in the state of Nevada
12 since 2001 and the Court appointed me to represent indigent
13 Defendant JAQUAN GAMBOA in the present matter.

14 2. Though he did not graduate, GAMBOA attended both Del Sol
15 and Bonanza High Schools in Nevada.

16 3. After leaving high school, GAMBOA worked at the convenience
17 store/smoke shop that his family owned in Las Vegas.

18 4. In addition to his mother April Gamboa (with whom I have
19 spoken many times), GAMBOA has approximately 50 family members
20 who live in Clark County.

21
22 5. If released from custody, GAMBOA will either live with his
23 girlfriend or a family member and work at the store that his
24 mother owns.

25 ///

1 6. Though I do not have access to Defendant's SCOPE and/or
2 NCIC, the Las Vegas Justice Court Nevada Pretrial Risk
3 Assessment form indicates that GAMBOA has three prior felony
4 convictions (arising from two cases), zero Gross Misdemeanors,
5 zero Misdemeanors and zero failures to appear.

6 7. I will personally advise GAMBOA that if he fails to appear
7 at any future hearing, does not maintain contact with my office
8 and/or does not stay out of trouble if released, the Court will
9 issue a bench warrant and keep him in custody throughout the
10 entirety of the case.

11 8. Based on the foregoing, I believe that the Court should set
12 bail at the total amount of \$10,000.00 (ten thousand dollars).

PRE-TRIAL DETENTION ORDER

Based on the allegations set forth in the Information, the information the State has provided, and the information provided by Mr. Gamboa's counsel, the Court having considered requirements of Valdez-Jimenez and statutory factors relevant to ensure that the Defendant will return to court and assess the risk of danger to the community, the Court finds as follows:

1. A No Bail hold, as was in place in this matter is unreasonable in light of the fact that Mr. Gamboa has completed serving the sentence which was in effect at the time of his Indictment in the instant matter.
2. The State failed to prove by clear and convincing evidence that a no bail hold is appropriate in this matter.
3. The Court, having considered the individual circumstances of Mr. Gamboa, finds that a release on personal recognizance would not reliably ensure the safety of the community.

- 1 4. Although Mr Gamboa does not appear to be a flight risk as his family resides in
2 the Las Vegas area as does Mr. Gamboa during his periods of non-incarceration,
3 the State did prove by clear and convincing evidence that there is no combination
4 of non-monetary conditions of release that will ensure community safety. The
5 evidence proved by the State includes:
- 6 a. That Mr. Gamboa was on parole for a Burglary (similar to the charges at hand)
7 at the time that the instant offense is alleged to have been committed by him;
 - 8 b. That the instant charges are likely to result in conviction as there is DNA
9 linking Mr. Gamboa to the crime;
 - 10 c. That the offense at hand was especially dangerous in that one of Mr. Gamboa's
11 alleged co-defendants was shot by the alleged victim and the other was held at
12 gunpoint by the alleged victim while awaiting police response;
 - 13 d. That Mr. Gamboa, at a young age, has an extensive criminal history consisting
14 of previous prison sentences in at least two prior cases;
 - 15 e. That these convictions are as follows:
 - 16 i. A 2016 conviction for Battery with a Deadly Weapon in case C304414-
17 2;
 - 18 ii. A 2019 conviction in case C334009 for Burglary; and
 - 19 iii. That Mr. Gamboa was originally granted probation in the 2016 case but
20 had probation violations which resulted in his being sent to prison. This
21 shows that he has a history of failure to follow directives of the Court.
- 22 5. Based on the consideration of the factors above, the Court finds the state has
23 proven by clear and convincing evidence that no less restrictive means exists to
24 ensure community safety and return to court and therefore the request for pretrial
25 detention is GRANTED. In determining an appropriate bail, the Court has
26 considered any representation of the State as to Defendant's financial resources.
27 The Court has also considered the defendant's representations concerning his
28 financial resources, income, available assets and liabilities, the Court thereby
