**MOTION TO EXTEND TIME
TO RESPOND TO ORDER TO SHOW CAUSE**

Appellants request an extension of time of 60 days, through June 10, 2022, in which to file a response to this Court's March 11, 2022, order to show cause. This is the first such request. Without an extension, the response would be due April 11, 2022.

As the Court points out, appellants' appeal was filed after the timely submission of tolling motions. As a status report, the parties have submitted briefs at the district court's request regarding

jurisdiction to resolve the now fully-briefed tolling motions.

Undersigned counsel anticipates that the additional 60 days will allow defendants to narrow the issues on appeal and also give the district court an opportunity to determine whether it has jurisdiction to consider the present matters, or issue indicative rulings in accordance with NRCP 62.1.

In addition, lead appellate counsel was severely ill during much of the past two weeks, including during the time in which he was preparing for back-to-back *en banc* arguments in Docket Nos. 82467/82552 and 81344 scheduled for April 4 and 5. (The parties in Docket Nos. 82467/82552 settled shortly before the argument, but counsel had still dedicated much of the previous month to preparations for it.)
