**ORDER**

Attorneys Kenneth M. Roberts and David E. Krawczyk of the law firm Dempsey, Roberts & Smith, Ltd., have filed a notice informing this court that they have not been retained to represent or appear on behalf of respondents in this appeal. The clerk of this court shall remove counsel and the law firm of Dempsey, Roberts & Smith, Ltd. from the docket in this appeal.

Respondents Floyd Wayne Grimes, Elizabeth Grimes, Victoria Jean Halsey, Jalee Arnone, and Peter Arnone shall have 30 days from the date of this order to retain new counsel and cause counsel to file a notice of appearance in this court or to inform this court in writing that they intend to proceed in this appeal pro se. Respondent WBG Trust is directed, within 30 days, to retain new counsel and cause counsel to enter an appearance. WBG Trust is cautioned that neither business entities nor trusts may appear or file documents without counsel. NRAP 46A(b)(2); *Salman v. Newell*, 110 Nev. 1333, 1336, 885 P.2d 607, 608 (1994); *State v. Stu's Bail Bonds*, 115 Nev. 436, 436 n.1, 991 P.2d 469, 470 n.1 (1999). Accordingly, if WBG Trust fails to retain counsel, the trust may not file documents in this appeal.

Appellant's docketing statement was due to be filed on or before August 18, 2021. To date appellant has failed to file the docketing statement.<sup>1</sup> Appellant shall, within 7 days from the date of this order, file and serve the docketing statement in compliance with NRAP 14. *See also* NRAP 10(b) & 30(b)(1). Failure to comply timely with this order may result in the dismissal of this appeal. NRAP 14(c).

It is so ORDERED.
