1) Your honor Appellant Longstreet Filed An opening Brief with being Able to Properly Refer to the sentencing HEARING TRANSCRIPTS From the sentencing hearing held on JANUARY 25, And JANUARY 27, 2021 in Front of Judge Jasmin Lilly-Spells. The COURT REPORT NAME MARIA GARIBAY SAT At Both sentencing HEARINGS under CASE Number C-20-348182-1 and those transcripts ARE testimonial evidence that support the claim that (1) Appellant did NOT PLACE Any money on the counter when he made A Mistake And Accused the victim of taking the money off the counter, And (2) Appellant WAS intoxicated At the time he made the Mistake, which goes toward his Facts in Mitigation Entitling him to HABEAS CORPUS Relief under NRS 194.010 (5)(6). Which is the BASIS of his HABEAS CORPUS Re-sentencing.
