23	That Rex Alvin Land is guilty of the crime of	of Attempted Open or Gross Lewdness,		
24	Subsequent Offense, a violation of NRS 199.330, being an	attempt to violate NRS 201.210(1)(b), a		
25	category E felony, as charged in Count II of the Informatio	n, and that he be punished by		
26	imprisonment in the Nevada Department of Corrections for	the maximum term of thirty (30)		
27	months with the minimum parole eligibility of twelve (12)	months, to be served consecutively to the		
28	sentence imposed for Count I, with credit for zero (0) days	time served.		

It is further ordered that a special sentence of lifetime supervision commence after
any period of probation, any term of imprisonment, or after any period of release on parole.

It is further ordered that the Defendant shall register as a sex offender within fortyeight (48) hours of sentencing or his release from custody pursuant to NRS 179D.460.

The Court, having found that the sentence imposed for Count II be served
consecutively to the sentence imposed for Count I, finds that the maximum aggregate term of
imprisonment is one hundred fifty (150) months in the Nevada Department of Corrections, and the
minimum aggregate term of imprisonment is sixty (60) months in the Nevada Department of
Corrections.

It is further ordered that the Defendant shall pay the statutory Twenty-Five Dollars
(\$25.00) administrative assessment fee; that he shall submit to a DNA analysis test for the purpose
of determining genetic markers and pay a testing fee in the amount of One Hundred Fifty Dollars
(\$150.00); that he shall pay a Three Dollar (\$3.00) administrative assessment fee for obtaining a
biological specimen and conducting a genetic marker analysis; and that he shall reimburse Washoe
County in the amount of Five Hundred Dollars (\$500.00) for legal services rendered.

It is further ordered that the fees shall be subject to removal from the Defendant's
 books at the Washoe County Jail and/or the Nevada Department of Corrections. Any fine, fee,
 administrative assessment, or restitution ordered today (as reflected in this Judgment) constitutes a
 lien, as defined in NRS 176.275. Should the Defendant not pay these fines, fees, assessments, or
 restitution, collection efforts may be undertaken against him.
