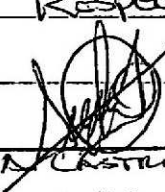
1 REQUEST TO AN OPPORTUNITY TO BE HEARD, AS TO THE

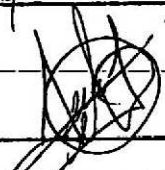
