18 Respondents Nationstar Mortgage LLC d/b/a Mr. Cooper and Wells Fargo Bank, National  
19 Association, as Trustee for Structured Adjustable Rate Mortgage Loan Trust Mortgage Pass-Through  
20 Certificates, Series 2007-3 (**Respondents**) hereby move for leave to file a response to Appellant Joe  
21 Beck's petition for an en banc rehearing of the Court's order dismissing the appeal.

22 On February 18, 2022, this Court entered an order *sua sponte* dismissing this appeal. On March  
23 7, 2022, the Appellant Joel Beck filed a petition to rehear the order dismissing the appeal, which was  
24 denied. On April 8, 2022, Joel Beck filed a petition for an en banc rehearing of the order dismissing  
25 the appeal.

26 Respondents request that the Court permit them to respond to Mr. Beck's petition for en banc  
27 rehearing. In the petition, Beck asks the Court to consider his appeal in the context of the wider case.  
28 The proposed opposition to his petition will provide the Court with that context necessary to evaluate

1 Mr. Beck's claims. It also provides the Court with exhibits of orders entered in the lower court for  
2 reference to the nature of the order being appealed and the past orders in the case. Respondents believe  
3 the Court will benefit from the information in reviewing the petition for rehearing, and the Court  
4 should grant leave to respond to the petition for rehearing.
