RESPONSE TO COURT ORDER

The Office of the Attorney General respectfully responds to this Court's March 4, 2022, Order in Case No. 84237, to provide "a certified copy of the notice of appeal log maintained at the prison indicating the actual date upon which appellant delivered to a prison official his notice of appeal." Order at 2.

Mark Sharp was not incarcerated at the time he filed his notice of appeal in this case, and he was not in the custody of the Nevada Department of Corrections. Sharp was paroled from custody in 2017, and he expired his sentence in May 2019. *See:* NDOC inmate search, attached hereto as Exhibit 1¹. Sharp filed his notice of appeal on February 15, 2022, nearly two years after his release from custody.

In the notice of appeal packet submitted by the petitioner and filed by this court on February 15, 2022, Sharp's Case Appeal Statement (page 4) sets forth
